3. The MoU can be terminated with three months notice on either side.
4. This agreement is governed by and construed in accordance with Indian Law.
5. The Head of the Department of Bioscience will be the Coordinator for the interaction on behalf of the College and the Industry will nominate a representative for the aforesaid.
6. The agreement is **valid for 3 years** and will be **auto renewed after every 3 years**, by both the parties until the termination process is initiated by either of the party.

## FORCE MAJEURE

No party shall be liable to the other if and to the extent, that the performance of any of its obligators under this agreement is prevented, restricted or interfered due to the circumstances beyond the reasonable control of such party including but not limited to Government Legislation, fire, flood, explosion, epidemics, accidents, Act of God, wars, riots, strikes, lockouts or other connected acts of workmen and act of Government.

## ARBITRATION

All disputes or differences whatsoever arising between the parties out of or relating to the construction, meaning and operation or effect of this contract or the breach thereof shall be settled by arbitration with the Rules of Arbitration of the Indian Council of Arbitration at Coimbatore only and the award made in pursuance thereof shall be binding on the parties. **VJ Biotech** has read this agreement, understands it and agrees to be bound by its terms and conditions. Further, **VJ Biotech** agrees that this, together with any supplement or schedule of charges, is the complete and exclusive statement of the agreement between the parties, which supersedes all proposals or prior agreements, oral or written, and all other communications between the parties relating to the subject matter of this agreement.
