- Industry to give consultancy support in various research projects and share the intellectual properties on mutual basis.

### **TERMS AND AGREEMENT**

- 1. Industry to support in hands on training and research for the students belonging to Excel College for Commerce and Science, Komarapalayam.
- 2. This is a non-exclusive agreement and is effective from 24<sup>th</sup> July, 2024 onwards.
- 3. For the services rendered by one party to other, the service charges, if applicable, shall be mutually agreed upon, and paid to the service provider.
- 4. The MoU can be terminated with three months notice on either side.
- 5. This agreement is governed by and construed in accordance with Indian Law.
- 6. The Head of the Department of Microbiology will be the Coordinator for the interaction on behalf of the College and the Industry will nominate a representative for the aforesaid.
- 7. The agreement is **valid for 3 years** up to 23.07.2027 and will be **auto renewed after every 3 years**, by both the parties until the termination process is initiated by either of the party.

### **FORCE MAJEURE**

No party shall be liable to the other if and to the extent, that the performance of any of its obligators under this agreement is prevented, restricted or interfered due to the circumstances beyond the reasonable control of such party including but not limited to Government Legislation, fire, flood, explosion, epidemics, accidents, Act of God, wars, riots, strikes, lockouts or other connected acts of workmen and act of Government.

#### ARBITRATION

All disputes or differences whatsoever arising between the parties out of or relating to the construction, meaning and operation or effect of this contract or the breach thereof shall be settled by arbitration with the Rules of Arbitration of the Indian Council of Arbitration at Komarapalayam only and the award made in pursuance thereof shall be binding on the parties.
