

Teaching Learning Process:

- At the beginning of each semester, the college level academic calendar will be developed with all
 essential details viz., reopening and closing dates, internal examinations dates, holidays, college
 level activities.
- The department prepares the academic calendar in align with the college calendar by including department specific activities and events. Each department distributes the calendar to all students and faculty members to plan their activities. The time table and the course plan are prepared well in advance.
- The faculty members are assigned courses based on their competency, subject expertise and experience. Each faculty member prepares the structured lesson plan, detailed course materials, question bank for theory subjects and lab manual for practical subjects as per guidelines given by IQAC.
- Faculty members incorporate the teaching pedagogy considering experiential learning, participative learning and problem solving methods in content delivery during their preparation. All the faculty members use ICT for effective teaching-learning process. Each faculty member is assigned with 15-20 students for mentoring.
- Class Committee meetings are conducted thrice during the semester. The chairperson of the
 committee communicate the rules and regulations of the department, examination procedure,
 discuss the syllabus completion and collect feedback on academic and administrative difficulties
 faced by the students.
- Based on the feedback, appropriate remedial measures are put into practice to improve the performance of the students. The major decisions/ improvements done based on the feedback received are communicated to the students.
- OBE is implemented in all programmes. The information on POs, PEOs and COs are communicated to the stakeholders. Student attainment of learning outcomes is measured by checking the level of CO and PO attainments for all the courses

Online Grievance Redressal Mechanism

Need:

- To ensure a fair, impartial and consistent mechanism for redressal of varied issues faced by the stakeholders
- To uphold the dignity of the University by promoting cordial Student-Student relationship, Student-teacher relationship, teacher-teacher relationship
- To develop a responsive and accountable attitude among the stakeholders, thereby maintaining a harmonious atmosphere in the University campus
- To ensure that grievances are resolved promptly, objectively and with sensitivity and in complete confidentiality
- To ensure that the views of each grievant and respondent are respected and that any party to a grievance is neither discriminated against nor victimized
- To advise stakeholders to respect the right and dignity of one another and not to behave in a vindictive manner towards any of them for any reason.

DEFINITIONS:

Grievance: Grievance means a formal complaint-includes any kind of content or dissatisfaction or negative perception, whether expressed or not, arising out of anything connected with University that a student or parent or staff member thinks, believes, or even feels, is unfair, unjust or inequitable.

Grievant: Grievant means a student, parent, staff member or group of students or parents or staff members submitting the grievance.

Days: Days means working days exclusive of Sundays, holidays or vacation days as set forth in the academic calendar. In counting days, the first day shall be the first full working day following the receipt of the grievance.

Analysis and Prevention:

Grievances are viewed as free inputs to understand the expectations of service recipients better and initiate systemic reforms to meet those expectations. All Bureaus therefore must analyze why they are receiving particular types of grievances more frequently

than others. Such grievance prone areas need to be identified and analyzed for bringing about necessary changes proactively.

Level of Responsibility for Redressal:

In order to ensure that grievances are addressed within the prescribed time norms, the Grievance Redressal Mechanism should define the levels of responsibility for redress of each category of grievances and their time norms. In case the grievance is not redressed at a particular defined level then an avenue should be available to the complainant to approach the next higher authority. The responsible officials at each level alert their next superior official well in time if a grievance is likely to exceed the prescribed time norm. The next higher authority should call for a report to redress escalated grievances.
