Again, the Principal of the said College has requested to issue of Letter of Consent of Affiliation to start M.Pharm Degree Course vide letter 3rd cited alongwith the Orders of the High Court of Madras in the reference 4th cited. Based on the W.P. No.1670 of 2022 and W.M.P. No.1813 &1814 of 2021, an Inspection was conducted on 10.09.2022, without prejudice to the rights of this University to appeal against the court order dated 01.02.2022 passed in W.P. No.1670 of 2022 and W.M.P. No.1813 &1814 of 2021 and subject to outcome of writ appeal to be filed before the Hon'ble Divisional Bench of Madras, High Court by this University and as per the Statutes No. 42 of the Tamil Nadu Dr. M.G.R. Medical University (Affiliation of Pharmacy Colleges) Statutes, the University issues the Consent of Affiliation (in Form-II annexed) to Excel College of Pharmacy, Namakkal to start M.Pharmacy Degree Course with three branches viz. Pharmaceutics and Pharmacy Practice
- 3. You are instructed not to admit any student in the above said branch in M. Pharmacy Degree course till the Provisional Affiliation Order is granted by this University. You are also instructed not to advertise through any media or in any form in this regard. You are further informed that the students admitted before the issue of Provisional Affiliation orders will not be registered by this University.

4. I am to request you to submit the Form – III along with the copy of the approval of the Pharmacy Council of India, New Delhi with Branch wise intake.
