Again, the Principal of the said College has requested to issue of Letter of Consent of Affiliation to start Pharm.D Course vide letter 3<sup>rd</sup> cited alongwith the Orders of the High Court of Madras in the reference 4<sup>th</sup> cited. No.1813 &1814 of 2021, an Inspection was conducted on 10.09.2022, **without prejudice to the rights of this University to appeal against the court order dated 01.02.2022 passed in W.P. No.1813 &1814 of 2021 and subject to outcome of writ appeal to be filed before the Hon'ble Divisional Bench of Madras, High Court by this University** for issue of LCA for starting of Pharm.D Course.

3. Based on the Inspection Report and the documents submitted by the Institution. I am to herewith enclosed the "Consent of Affiliation" in the format prescribed by the Pharmacy Council of India, New Delhi for starting of Pharm.D Course. Further, it is informed that, the Institution should not start the proposed Programme in any form, till the University grants Provisional Affiliation for starting of Pharm.D Programmed. ## **CONSENT OF AFFILIATION**

**“This Consent of Affiliation is being issued, without prejudice to the rights of this University to appeal against the court order dated 01.02.2022 passed in W.P. No.1670 of 2022 and W.M.P. No.1813 &1814 of 2021 and subject to outcome of writ appeal to be filed before the Hon’ble Divisional Bench of Madras, High Court by this University”.**

On the basis of the Preliminary inquiry report, the University grants Consent of Affiliation to Excel College of Pharmacy, Ranganoor Road, Sankari West (PO), Komarapalayam, Namakkal for starting of Pharm.D Course, subject to the grant of approval by the Pharmacy Council of India (PCI), New Delhi under section 12 of the Pharmacy Act 1948. The applicant college shall be allowed to start Pharm.D. programme only after obtaining the approval for conduct of the course of study from the Pharmacy Council of India.

The University also undertakes to conduct the examination as prescribed in the Pharm.D. Regulations 2008 of Pharmacy Council of India.

This Certificate is valid for a period of two years from the date of issue.
